This is to give you notice that Americana, LLC doing business as Berkshire Hathaway HomeServices Nevada Properties (“Berkshire Hathaway HomeServices Nevada Properties”), HomeServices Relocation, LLC, Prosperity Home Mortgage, LLC, Equity Title, LLC doing business as Equity Title of Nevada (“Equity Title of Nevada”), HomeServices Insurance, Inc. doing business as HomeServices Insurance Agency (“HomeServices Insurance Agency”), and Title Resources Guaranty Company (“TRG”) are part of a family of companies (the “Affiliated Companies”) owned by HomeServices of America, Inc. (“HSOA”), and each may refer to you the services of another. Berkshire Hathaway HomeServices Nevada Properties, HomeServices Relocation, LLC, Prosperity Home Mortgage, LLC and HomeServices Insurance Agency are each wholly owned by HSOA, either directly or through one or more subsidiaries. HSOA also indirectly owns 47.5% of Equity Title of Nevada. HomeServices Title Holdings, LLC, a wholly-owned subsidiary of HSOA, indirectly owns 11.5% of TRG. Because of these relationships, the referral of a customer (including you) by any of the Affiliated Companies to another may provide the referring company, its affiliates, and/or their employees or agents with a financial or other benefit.
